TERMS OF ENROLLMENT AGREEMENT

1. This contract is made for enrollment options selected on the Enrollment Agreement. Signature(s) on the reverse side of this form represent responsibility for payment of camp tuition.
2. Upon a mutually agreed early withdrawal of a camper, a pro-rated refund (minus 1 week's tuition charge) will be returned.
3. The Directors reserve the right to deny, cancel or suspend a child's enrollment if deemed in the best interest of the camper or the Camp, in which case the deposit or unused camp fee will be refunded.
4. No reduction or allowance will be made for any interruption in the camp season due to illness or absence.
5. All outstanding balances for tuition are due in full by May 15, 2013.
6. A \$20.00 fee will be charged for any returned checks.
7. Camper and parents agree to abide by the rules and regulations set by the Directors for the health, safety and welfare of the campers.
8. The Camp is not responsible for a camper's equipment or personal belongings while in transit or at camp, or if lost or damaged by fire, theft or otherwise. The Camp will make every effort to provide proper supervision so that losses will be at a minimum.
9. A completed Health Form must be on file in the Camp Office by June 1st.
10. Camp carries a secondary medical insurance policy. All medical claims must be submitted to the primary (camper's) carrier before the Camp policy is in force.
11. Special requests for placement will be honored only if deemed in the best interest of the camper, the group and the Camp, and must be submitted in writing.
12. Parent's signature further gives camper permission to participate in all regular programs and electives, special events and activities, and off-campus trips.
13. I am aware of the inherent dangers and risks involved in summer camp activities, swimming, climbing and adventure activities, sports and general active play. I agree to indemnify and hold harmless Elbow Lane Day Camp and the Owners, Directors and Staff from any and all claims, actions, suits, expenses and liabilities for injury resulting from participation in these and other camp programs.
